



## ART AT THE BALLPARK 2010 INFORMATION & APPLICATION

1. The Art at the Ballpark event is presented and produced in conjunction with The Great Lakes Irish Music Festival. Application must be made in the name of the individual artist. All work must be attributable solely to the displaying applicant.
2. **Cost for each exhibit space is \$50.00, payable at time of application.** Please mail a check with your application made out to Art at the Ballpark 2010. If application is sent prior to July 1, 2010 the **early bird fee is \$40.00 per booth space.** **Deadline for applications is August 1, 2010.**
3. Sending a photo of your work, one of your booth - if available, and one of the artist working on his/her craft, with your application, is highly encouraged for our Festival Website. In addition, we will promote all our participating artists, in advance, with a link from our website to yours, if available.
4. Categories are Art (paintings, pencil, oil, watercolor) Sculpture, Ceramics (greenware or pottery) Jewelry, Photography, Wood, Textile (no clothing, please) and Glass.
5. Artists will exhibit and sell their original works. Only hand-constructed wares are to be sold. No commercial products are permitted.
6. The **Art Fair will be held on Saturday, August 7, 2010.** It will be **open to the public on Saturday from 12 Noon - 6:00 PM.** This is a non-juried show. **A Best in Show Prize will be awarded on the day of the Festival in the amount of \$125.00. People's Choice Award will be given on the day of the Festival in the amount of \$75.00.** Both prizes will be awarded at 6:00 PM, that day.
7. An accepted artist to Art at the Ballpark will be notified within one month of application receipt, or sooner. Instructions, credentials, parking passes, maps, booth location will be mailed in late July.

### **BOOTH SPACE:**

The cost for each exhibit space (8'x8') includes electricity. (supply your own 100 foot, 3 prong grounded UL listed electrical extension cords for your electrical appliance usage-zip cords, household, are not acceptable) 1 parking pass and 2 exhibitor passes. Booth sharing is not permitted. Booth space is assigned on a first-come, first-serve basis. Applications will be date stamped as they are received

Load in will begin at 7:00 AM on Saturday, August 7, 2010.

Only pre-approved artists are permitted. No artist may assign, delegate, resell their booth space or transfer their right to participate in Art at the Ballpark.

Agents representing the artist are not allowed. All work must be shown by the artist who rents the space. Artists should wear credentials when working and will be required to display an artist pass before entering the Festival Grounds. All applicants are required to be present for the duration of the Art Fair with their exhibits.

Exhibitors may not sell food or drink of any kind. Violation will result in dismissal from the event. All signs must have a professional look. All exhibitors must maintain an attractive display. Sales of T-shirts or sweatshirts by individual artists are prohibited, as no clothing may be sold at The Art at the Ballpark site.

Exhibitors are responsible for keeping their areas tidy. Please bring a plastic trash bag to aid in cleanup. Artists must have a trash receptacle in their booth. No flames of any kind are permitted.

Artists may not leave their booth to solicit sales or distribute information.

Artists are located under a protected area. There will be no "rain date" and fees will not be refunded in the case of inclement weather.

Artists are responsible for their own sales tax liability by collecting and submitting the appropriate sales tax incurred at the event, themselves.
